## Office of Senator Warnock – FY27 Congressionally Directed Spending (CDS) Request Form

Please use this form to submit your request for Fiscal Year 2027 (FY27) CDS funding by **March 2, 2026, at 5 PM Eastern Time (EST)**. Programmatic requests **will NOT** be accepted if submitted via this form. A **programmatic request** is a request to fund a specific federal program in the appropriations bill at a specified level. All requests must comply with Rule XLIV of the Standing Rules of the Senate (<https://www.rules.senate.gov/rules-of-the-senate>). Among other provisions, Rule XLIV bars members from carrying any financial or pecuniary interest in any CDS project they support and requires members to disclose their requested CDS projects.

In previous years, CDS funding has been limited to public and nonprofit entities, and a random sample of funded projects was audited by the Government Accountability Office. Generally, CDS funding cannot be used as a continuous funding source. All CDS projects must comply with these rules and requirements. CDS requirements may change based on further guidance from the Senate Appropriations Committee, and CDS funding is contingent on enactment of FY27 appropriations bills.

You may submit multiple appropriations requests. Please fill out a separate application for each

request. Some of the questions are required—you will not be able to submit the form unless these questions are answered. Additionally, some questions will require additional information depending on your answers. **You will not be able to save your progress as you complete the application.** We strongly recommend that you work from an external document and copy information into the form when you are ready to submit.

The office encourages you to submit your request as early as possible. ## Agriculture, Rural Development, Food and Drug Administration, and Related Agencies

Below is guidance for CDS within the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations bill. The office anticipates the following accounts to be eligible sources of CDS funding:

### Rural Development - Community Facilities (CF) Grants

This account will fund **up to 75** percent of total project costs depending on the community's population and median income. All projects must meet environmental review requirements. The match requirements are outlined in the CF regulation 7 CFR 3570.63(b). Applicants must complete an application if awarded a CDS in the final bill.

### Rural Development - Distance Learning, Telemedicine, and Broadband Program (DLT) Grants

All applicants must be able to satisfy the program's flat 15 percent non-federal matching funds requirement prior to a CDS request being approved. Broadband deployment is **not** an eligible use of funds for DLT. A full list of eligible entities, uses, and limitations are listed in 7 CFR Part 1734 Subpart A and B. Applicants must complete an application if awarded a CDS in the final bill.

### Natural Resources Conservation Services (NRCS) - Watershed and Flood Prevention Operations (WFPO)

An applicant must have a local sponsor, certify coordination with their NRCS state office, and ensure the proposal meets all program requirements, including financial requirements. At least 20 percent of the total benefits of the project must be directly related to agriculture.

### Agricultural Research Service - Building and Facilities (ARS B&F)

Requests for ARS B&F may only include funding for existing facilities or facilities where funding has been provided in the past. Facilities must be ARS-owned.

### Animal and Plant Health Inspection Service - Salaries and Expenses:

Projects must meet environmental review requirements (e.g., the National Environmental Policy Act and the Endangered Species Act). While the entire S&E account is open for CDS requests, below are the line items within the account that are most compatible with CDS:

- Field Crop & Rangeland Ecosystems Pests
- Pest Detection
- Plant Protection Methods Development
- Specialty Crop Pests
- Tree & Wood Pests
- Wildlife Damage Management

- Wildlife Services Methods Development
- Veterinary Diagnostics
- Equine, Cervid and Small Ruminant Health

Additionally, the following APHIS programs have matching requirements:

- Grasshopper/Mormon Cricket (Field Crop & Rangeland Ecosystems Pests) – 100 percent on Federal land (including most tribal trust lands), 50 percent of the cost on state land, and 33 percent of the cost on private land
- Brucellosis (Cattle Health) – 40 percent match
- Wildlife Services – 50 percent match

***Commerce, Justice, Science, and Related Agencies***

Below is guidance for CDS within the Commerce, Justice, Science, and Related Agencies Appropriations bill. Successful projects will match the project to the authorization or mission of an agency or account and have the support of local officials or communities. The office anticipates the following accounts to be eligible sources of CDS funding:

***Department of Justice - Office of Justice Programs, State and Local Law Enforcement Assistance, Byrne Discretionary***

All projects must have a nexus to the criminal justice system. Projects should provide additional personnel, equipment, supplies, contractual support, training, technical assistance, and information systems for criminal justice systems. Awarded grants will be subject to the

requirements of 2 CFR Part 200 and the DOJ Grants Financial Guide. Allowable costs are those costs consistent with the principles set out in 2 CFR Part 200, Subpart E, and those permitted by the grant program's authorizing legislation. To be allowable under Federal awards, costs must be reasonable, allocable, and necessary to the project, and they must also comply with the funding statute and agency requirements. This funding cannot be used for land acquisition or construction.

### **Department of Justice - Community Oriented Policing Services (COPS), COPS Law Enforcement Technology and Equipment**

Projects should provide for the development of technologies and automated systems to assist law enforcement agencies in investigating, responding to, and preventing crime. Allowable activities are limited to the statutorily allowable purpose areas under the COPS Office statute. Awarded grants will be subject to the requirements of 2 CFR Part 200 and the DOJ Grants Financial Guide and the applicable Award Owner's Manual.

### **National Institute of Standards and Technology (NIST) - Scientific and Technical Research Services (STRS); External Projects**

Projects should address scientific, technological, and standards-related research and technology development, limited to equipment and limited contracting. There must be a clear, demonstrable nexus to the research component of the project and to a NIST research program. Construction projects will not be accepted.

### **National Institute of Standards and Technology (NIST) - Construction of Research Facilities; Extramural Construction**

The Committee will accept CDS for NIST Construction projects for non-Federal research facilities, including projects at research institutions and colleges and universities.

### **National Oceanic and Atmospheric Administration (NOAA) - Operations, Research, and Facilities (ORF); Special Projects**

Projects should address fisheries, marine mammals, oceans, coastal issues, climate, weather, atmospheric research, data acquisition, and forecasting programs. Construction projects will not be accepted.

### **National Aeronautics and Space Administration (NASA) - Safety, Security and Mission Support (SSMS)**

Projects should focus on science education, research, and technology development related to NASA's mission. Medical research projects and projects at NASA-owned Visitor Centers or a State's designated Space Grant Consortium will not be funded. This account does not fund construction but could be used for equipment, research funding, or education programs.

### ***Energy and Water Development and Related Agencies***

Below is guidance for CDS within the Energy and Water Development, and Related Agencies Appropriations bill. The office anticipates the following accounts to be eligible sources of CDS funding:

#### **Department of Energy**

While the Subcommittee will consider requests in the Department of Energy, it is expected to

provide very few such items. The Committee **will not fund** the following projects:

- Projects that require multiple years of funding – the funding requested should reflect a funding amount that can complete the project;
- Construction of buildings or new facilities (no brick and mortar), even if it will have clean energy associated with it;
- Vehicle charging projects, unless the project is connected to larger clean energy sources (like a battery) or has clean energy applications beyond the charging station;
- Electrical substation replacement or routine grid upgrades that could otherwise be funded under ratepayer contracts or through existing federal incentives;
- Planning studies for a forthcoming project, including planning studies for NetZero goals;
- Clean energy projects that do not show a transformative or emerging technological solution (i.e., solar panels, battery storage, or light bulb upgrades without any transformative technology or integrated energy systems associated with it).

Statutory cost sharing requirements may apply to these projects, as required by section 988 of the Energy Policy Act of 2005. The amount of required cost sharing will depend on the scope and technological maturity of the project. The following are the general cost share assumptions:

- Research or development activities of a basic or fundamental nature: no minimum cost share.
- Research or development activities of an applied nature: minimum 20 percent cost share
- Demonstration or commercial application: minimum 50 percent cost share.
- Some projects may contain elements of more than one of the categories shown above. Therefore, some projects may have a blended cost share.

Further, this year's requests will be submitted into a single Department of Energy earmark account, and requests must fit under at least one of the five topic areas listed in the Department of Energy: "Energy Projects" below:

- Energy Efficiency and Renewable energy
- Electricity
- Cybersecurity, Energy Security, and Emergency Response
- Nuclear Energy
- Fossil Energy and Carbon Management

### **Corps of Engineers**

For the Corps of Engineers, only authorized projects and programs will be considered for funding. With the exception of Operation and Maintenance, an authorized project or program that has not received funding in prior years is considered a new start. Few, if any, new starts will be funded. Similarly, few, if any, Environmental Infrastructure projects will receive funding.

## Financial Services and General Government

Below is guidance for CDS within the Financial Services and General Government (FSGG) Appropriations bill. The office anticipates the following accounts to be eligible sources of CDS funding:

### Small Business Administration - Administrative Provision (SBA)

Eligible projects include those that support small business entrepreneur training, counseling, and research. Projects should align with the goals of SBA’s existing grant programs. Unfortunately, requests for seed capital for small businesses, sub-grants or loans, or the construction or acquisition of facilities are **NOT eligible** for CDS funding.

### National Archives and Records Administration, National Historic Publication and Records Commission (NPRC)

Eligible projects include those to help ensure online public discovery and use of historical records collections, encourage public engagement with historical records, strengthen the nation’s archival network, or publish documentary editions of historical records. This includes initiatives like record digitization, programming, and online availability of records. You may find NPPRC eligibility requirements [here: https://www.archives.gov/npprc/apply/eligibility.html](https://www.archives.gov/npprc/apply/eligibility.html).

### National Archives and Records Administration, Repairs and Restoration

Eligible projects are those that dedicate funding for one or more of the 15 presidential libraries established under the Presidential Libraries Act.

### General Services Administration, Federal Buildings Fund, Construction and Acquisition or Repairs and Alterations Accounts

Eligible projects include all Construction projects and Major Repairs projects not requested in

the FY27 GSA budget request, unless projects were partially funded in a prior enacted FSGG Appropriations bill. Construction projects typically include federal courthouses, federal buildings, or land ports-of-entry. Repair projects must be federally-owned properties in need of major repairs or alterations and are typically federal buildings or federal courthouses. State or county facilities, Department of Defense facilities, Veterans Affairs facilities, and transportation infrastructure facilities are **NOT eligible**.

**Office of National Drug Control Policy, Administrative Provision (Prevention Grants)**

Eligible projects include evidence-based drug-related projects such as primary prevention of substance use disorder, community-based coalitions that propose evidence-based prevention interventions, and Drug Free Communities-funded coalitions recently trained to implement Adverse Childhood Experiences as part of their substance use prevention efforts. Eligible expenses include staff salaries and benefits for time spent on the project, building rent, and equipment. Substance-specific programs, treatment programs, property purchases, construction, and renovation costs are **NOT eligible**.

## Homeland Security

Below is guidance for CDS within the Homeland Security Appropriations bill. The office anticipates the following accounts to be eligible sources of CDS funding:

Projects awarded BRIC funding are **NOT eligible** for PDM CDS funding.

### **Federal Emergency Management Agency - Emergency Operations Center (EOC) Grant Program**

### **Interior, Environment, and Related Agencies**

Below is guidance for CDS within the Interior, Environment, and Related Agencies Appropriations bill. The office anticipates the following accounts to be eligible sources of CDS funding:

#### **Environmental Protection Agency (EPA) - Water and Wastewater Infrastructure**

Eligible projects include those listed on a state's most recently finalized [Clean Water or Drinking](#)

[Water State Revolving Fund Intended Use Plan \(IUP\)](#), as well as projects that are eligible for funding under State Revolving Loan Fund (SRF) guidelines, but are not on the IUP list. There is a minimum 20% cost-share requirement for any project – for example, a \$1 million project could receive a maximum \$800,000 CDS award, with the remaining \$200,000 the responsibility of the CDS recipient. In almost all cases, other sources of federal funding cannot be used to meet the cost-share requirement. Only the non-federal portion of assistance provided by an existing SRF loan can be applied to a project's matching requirement. Please note that CDS projects included in a final bill will go through the federal grant award process and be subject to applicable requirements including those related to federal grants, domestic preference, and the National Environmental Policy Act.

#### **National Park Service - Historic Preservation Fund (HPF)**

### ***Labor, Health and Human Services, Education, and Related Agencies***

Funds made available under the LHHS Subcommittee cannot be used to acquire land or property. The Health Resources and Services Administration – Health Facilities Construction and Equipment sub-account is the **ONLY** sub-account under LHHS that may be used for the construction or renovation of facilities. **Department of Labor - Employment and Training Administration (ETA), Training and Employment Services**

CDS projects funded by ETA must be focused on meeting the employment and training needs of workers. These projects should include direct services which could include career services, training services, supportive services, and other permissible services, as they are defined in the Workforce Innovation and Opportunity Act (WIOA). Projects will be required to report on performance outcomes for participants and should include a meaningful connection to the local workforce development system. Some CDS funding may be used for the purchase of equipment or curriculum development. If a significant amount of CDS funding is to be used for equipment or curriculum development, provide a detailed justification for how such costs relate to the employment and training needs of individuals. This category will not fund wrap around services such as food or clothing. There must be a clear connection to how the request ties back to the workforce.

**Department of Health and Human Services - Health Resources and Services Administration (HRSA)**

Projects must fall under one of the following categories: Health Facilities Construction and Equipment or Rural Health. Funding is generally used for construction/renovation and the purchase of equipment associated with healthcare facilities. Generally, any equipment having a useful life of more than one year and a unit cost of at least \$5,000 will be eligible. Funding provided under the Rural Health account must be used for services in areas that meet HRSA's definition of rural. You may find HRSA's definition of rural here: <https://www.hrsa.gov/rural-health/about-us/what-is-rural>. Funds cannot be used to pay salaries, purchase existing buildings/acquire land, or reimburse work previously completed. CDS recipients may not sub-grant to other organizations or agencies. The subcommittee will not accept any request for funding of over \$15,000,000.

**Department of Health and Human Services – Substance Abuse and Mental Health Services Administration (SAMHSA), Health Surveillance and Program Support**

Projects must fall under one of the following categories: Mental Health, Substance Abuse Treatment, or Substance Abuse Prevention. The subcommittee is prohibited from funding projects that distribute sterile needles or syringes for IV drug injection or promote the legalization of illegal drugs or substances. In previous fiscal years, the subcommittee has only accepted 8 SAMHSA requests per Senator.

**Department of Health and Human Services – Administration for Children and Families**

Projects must fall under one of the following categories: Child Abuse Prevention or Social Services Research and Demonstration.

**Department of Health and Human Services – Administration for Community Living**

Projects must improve the ability of older adults and individuals of all ages with disabilities to live independently and participate fully in their communities.

**Department of Education – Innovation and Improvement, Fund for the Improvement of**

## **Education**

CDS funding under this account can support a wide variety of projects that help provide early childhood or K-12 educational services, including curricula development, early childhood education, afterschool centers, and teacher training. Eligible grantees include state education agencies, school districts, colleges and universities, and other public and private nonprofit entities.

## **Department of Education – Higher Education, Fund for the Improvement of Postsecondary Education (FIPSE)**

CDS funding under this account can support a wide variety of projects that improve access to, and quality of, postsecondary education, including hiring, training, curricula development, and student support. Eligible grantees include colleges and universities and other public and nonprofit organizations. CDS funding under FIPSE cannot be used for endowments.

## **Transportation, Housing and Urban Development, and Related Agencies**

The subcommittee will not fund CDS requests for operational expenses or administrative salaries and benefits. All CDS funding will be provided on a reimbursement basis and recipients will be required to request drawdowns from their CDS awards as eligible expenses are incurred.

Expenses incurred prior to the enactment of a final FY 2027 appropriations bill are not eligible for reimbursement. All CDS funding must have a reasonable expectation of being obligated by the end of FY 2029.

All DOT CDS projects will have a non-Federal cost-share requirement, consistent with the authorized program under which the project is funded. The cost share may vary by State, community, or type of project, and it is recommended that you consult with DOT for the cost-share requirements of any specific project. Most DOT CDS projects will also require an eligible non-federal sponsor to administer the funds.

The office anticipates the following accounts to be eligible sources of CDS funding:

### **Department of Transportation - Transportation Planning, Research, and Development (TPR&D)**

The subcommittee will only consider projects eligible under Title 23 or Title 49, U.S. Code. This account is designed for national or regional planning, research, and development projects. Planning for specific local highway, transit, rail, or port projects that are eligible under HIP, TIG, CRISI, or PIDP (see below) should NOT be included in this account.

### **Department of Transportation - Grants-in-Aid for Airports (AIP)**

The subcommittee will only consider projects eligible under Chapter 471 of Title 49, U.S. Code. (<https://www.faa.gov/airports/aip/overview>). AIP CDS follows the existing AIP statute, and the Federal cost-share requirements still apply to CDS. For small primary, reliever, and general aviation airports, CDS can cover a range of 90-95 percent of eligible costs, based on statutory requirements.

Operational expenses are not eligible. The total cost of the project should be consistent with the total cost listed in the STIP or TIP. All highway CDS will be provided directly to Georgia Department of Transportation (GDOT) for administration.

### **Department of Transportation - Transit Infrastructure Grant (TIG)**

The subcommittee will only consider projects eligible under Chapter 53 of Title 49, U.S. Code. Please be prepared to provide the name of the recipient transit agency, total cost of the project, and whether the project is included, or eligible to be included on the STIP or TIP. The total cost of the project should be consistent with the total cost listed in the STIP or TIP.

### **Department of Transportation - Consolidated Rail Infrastructure and Safety Improvement (CRISI) Grants**
